****DVR recording of incident****

One unidentified suspect outstanding: H/M, 20's, shaved head, white t-shirt, baggy jeans, 3-4" goatee. May have put a blk zip-up over the white t-shirt.

S/██████████ detained at the scene and transported to ██████ via AMR for treatment of his injuries.

S/██████████ taken into custody just north of the ██████████; after he was found hiding under a vehicle. He was transported to the West Precinct and I & R'd at 0230 hours.

S/██████████ was taken into custody just north of the ██████████. He was transported to the West Precinct and I & R'd at 0230 hours.

V/██████████ was transported to ██████ via AMR for a stab wound to the right hip flexor. According to SFD, the wound will require stitches.

V/██████████ had a small laceration to the back of his head after being struck by a beer bottle (which shattered). Treatment not required.

At 0112 hours, officers were dispatched to the ██████████, 12███ Westlake Ave N, on a reported stabbing just occurred. The callers reported that several males were fighting with security and that at least one subject had a knife. As officers were arriving, dispatch advised that the suspects were leaving northbound on foot and one security guard had been stabbed in the leg. V/██████████, a security guard wearing a marked "security" shirt, was located in the parking lot, with a stab wound to the right leg. V/██████████, along with several other security guards, were pointing northbound, advising that the suspects were on foot through the parking lot. Before being treated by SFD, V/██████████ was able to relay the following information:

He was working inside the door when he was alerted to a disturbance involving 5 Hispanic males inside the club. The males were asked to leave by other security personnel and V/██████████ was one of the employees that escorted them to the front door. The 5 males spoke amongst each other in Spanish just prior to exiting the club, and once they got outside, they turned on security and two of them pulled out knives. V/██████████ was stabbed in the right leg by the outstanding suspect, and V/██████████ was hit in the head from behind by an unknown suspect with a beer bottle. A melee ensued in the parking lot between the security staff and the 5 Hispanic males (the 3 named above, the one outstanding, and an additional unknown male).

According to V/██████████, after he was stabbed with an exacto knife, he took it from the suspect and threw it across the parking lot. The physical fight continued and moved northbound, until the suspects retreated and ran off, as officers were arriving.

Approximately three minutes after the call, S/██████████ and S/██████████ were located in the 15th block of Westlake Ave N. S/██████████ had an obvious head wound and SFD was called for his injuries. At 0127 hours, S/██████████ was located hiding underneath a vehicle in the 13th block of Westlake Ave N (east side) and he was taken into custody. S/██████████ and S/██████████ both said that their injuries were from fighting with security.

An extensive area check was conducted for the outstanding stabbing suspect with negative results. It was initially thought that he may have left in a silver Toyota Prius, however that could not be verified. None of the suspects taken into custody would identify their friend that had stabbed V/██████████. It's unknown which suspect struck V/██████████ with the bottle, as none of the security team could identify the person.

The exacto knife could not be located in the parking lot. Security advised that the group involved were not regulars at the club, but that they believed they belonged to "██████████" (based on a sign flashed as they were leaving).

The incident was screened by Sgt Lamb at the scene.
